NOTICE OF THE TRANSFER OF A PORTION OF THE INSURANCE BUSINESS OF LION OF AFRICA LIFE ASSURANCE COMPANY LIMITED TO EMERALD LIFE PROPRIETARY LIMITED IN TERMS OF SECTION 50 OF THE INSURANCE ACT

It is the intention of Lion of Africa Life Assurance Company Limited (registration number 1942/015587/06) ("**Lion Life**") to transfer a portion of its insurance business to Emerald Life Proprietary Limited (registration number: 2016/534835/07) ("**Emerald Life**") in terms of section 50 of the Insurance Act 18 of 2017 ("**Act**") ("**Proposed Transfer**").

The policies affected by the Proposed Transfer constitutes:

1. 100% of the funeral insurance policies underwritten by Lion Life, and distributed and administered by Emerald Life, in terms whereof premiums are paid by means of a deduction other than deductions from social grants in terms of regulation 29(1) of the regulations published under the Social Assistance Act, 2004; and
2. 50% of the funeral insurance policies agreed to between Lion Life and Emerald Life which policies are underwritten by Lion Life, and distributed and administered by Emerald Life, in terms whereof premiums are paid by means of deductions from social grants in terms of regulation 29(1) of the regulations published under the Social Assistance Act, 2004,

collectively the "**Transfer Policies**".

The Transfer Policies will be transferred to Emerald Life in terms of a transfer of business agreement concluded between Lion Life and Emerald Life ("**Agreement**").

Because the Proposed Transfer involves a transfer of the Transfer Policies from Lion Life to Emerald Life without the policyholders' consent, a detailed regulatory process is required in terms of the Act, which includes, amongst others, the approval of the Proposed Transfer by the Prudential Authority.

Once the Prudential Authority approves the Proposed Transfer, Emerald Life will be responsible for carrying out all the obligations of Lion Life that relate to the Transfer Policies.

Details of the Proposed Transfer are contained in the Agreement. The Agreement is subject to the fulfilment of suspensive conditions, which include, amongst others, that the Prudential Authority approves the Proposed Transfer.

Copies of the Agreement and other documents relevant to the Proposed Transfer will be made available from 27 May 2026 to 17 July 2026 other than Saturdays, Sundays and Public Holidays ("**Inspection Period**") at:
