1. Ulwazi malunga neLion Life, i-Emerald Life kunye noDluliselo

1.1 Ngubani uLion Life

I-Lion of Africa Life Assurance Company Limited, inombolo yobhaliso 1942/015587/06 ("iLion Life") yinkampani kawonkewonke neyinkampani yee-inshorensi zobomi enemvume ebhaliswe eMzantsi Afrika.

1.2 Ngubani u-Emerald Life?

I-Emerald Life Proprietary Limited, inombolo yobhaliso 2016/534835/07 ("i-Emerald Life") yinkampani yabucala kwaye iyinkampani yee-inshorensi ezincinci enemvume ebhaliswe eMzantsi Afrika futhi ililungu leqela leenkampani ze-Emerald.

2. Ukudluliselwa kwePolisi ukusuka eLion Life ukuya e-Emerald Life

2.1 Kutheni iza kutshintsha inkampani ye-inshorensi yepolisi yam?

Kuvunyelwene phakathi kweLion Life kunye ne-Emerald Life ukuba kudluliselwe iipolisi ezichazwe apha ngezantsi kwi-Emerald Life, ngokuxhomekeke ekuvunyweni liGunya elijongene noLawulo lwamaZiko eMali neeNkampani ze-Inshorensi ("iPrudential Authority") njengoko kudingeka ngokwemimiselo yecandelo lama-50 le-Insurance Act ka-2017 ("i-Insurance Act"). I-Emerald Life izakuqhubeka iyiyo inkampani engumlawuli weepolisi kwaye ngokufanelekileyo yiyo ezakuba yinkampani yee-inshorensi emva kokuvunywa kodluliselo yiPrudential Authority ("Udluliselo Olucetywayo").

2.2 Zeziphi iipolisi ezichatshazelwayo ludluliselo?

Iipolisi Ezidluliswayo zonke zibandakanya iipolisi zee-inshorensi zokungcwaba ezimelwe nguLion Life nebezikade zithengiswa kwaye zilawulwa yi-Emerald Life ("Iipolisi Ezidluliswayo").

2.3 Ingaba kukho nakuphi okusecaleni ngokuphathelele kwiipolisi zee-inshorensi zokungcwaba ezichaphazelekayo?

2.3.1 Ewe, i-50% yeepolisi zee-inshorensi zokungcwaba ezimelwe nguLion Life, zize zikhutshwe kwaye zilawulwe yi-Emerald Life ngaphantsi kwemimiselo apho imirhumo ihlawulwa ngendlela yemali etsalwa kwizibonelelo zentlalontle ngokwemimiselo yommiselo u-29(1) wemimiselo epapashwe ngaphantsi kwe-Social Assistance Act ka-2004

nanjengoko kuvunyelwene phakathi kukaLion Life ne-Emerald Life, ziya kuqhubeka zimelwe nguLion Life. Kumele kananjalo ukuba ikhona i-SMS oyifumeneyo evela eLion Life eqinisekisa ukuba ipolisi yakho iza kuhlala iseLion Life.

2.3.2 Oku kuthetha ukuba xa ipolisi yakho ingadluliselwa, ipolisi yakho iya kuqhubeka imelwe nguLion Life kwaye akukhonto iya kutshintsha ngokuphathelele koko.

2.3.3 Ukuba imirhumo yakho ihlawulwa ngenye indlela engaphandle kokutsalwa ngqo kwiinkxaso-mali karhulumente ngokwesimiselo 29(1) semimiselo epapashwe phantsi kweSocial Assistance Act ka-2004, iya kudluliselwa ku-Lion Life iye ku-Emerald Life. Kusenokwenzeka ukuba ufumene iSMS evela nokuba ku-Emerald Life kunye/okanye eLion Life ukuqinisekisa ukuba ipolisi yakho iya kudluliselwa ku-Emerald Life.

2.4 **Zezipi iipolisi zokungcwaba ezichaphazelekayo?**

Ezi polisi ze-inshorensi zilandelayo ziyachaphazeleka:

- Ukuba ngaba iintlawulo zepolisi yakho zitsalwa kwisibonelelo sakho sezentlalontle kwaye ufumene i-SMS evela nokuba e-Emerald Life kunye/okanye e-Lion Life, ipolisi yakho iza kudluliselwa e-Emerald Life;
- Ukuba ngaba akukho SMS oyifumeneyo kwaye awuqinisekanga nokuba ngaba ipolisi yakho iyachaphazeleka na, nceda uqhagamshelane nalo naliphi na iziko leminxeba kula alandelayo, e-Emerald Life, ku-0861 666 333 kunye/okanye eLion Life ku-021 461 8233 okanye undwendwele isebe elikufutshane nawe:

2.5 **Ziza kudluliswa njani iipolisi?**

2.5.1 Iipolisi Ezidluliswayo ziza kudluliselwa e-Emerald Life njengenxalenye yodluliselo lwentengiselwano yeshishini oluqosheliswe phakathi kweLion Life kunye ne-Emerald Life. Oku kuthetha ukuba i-Emerald Life yiyo ezakuba yinkampani yee-inshorensi entsha yeePolisi Ezidluliswayo.

2.5.2 Esi sivumelwano sixhomekeke ekuvunyweni yiPrudential Authority (njengoko kudingeka ngokwemimiselo yoMthetho wee-Inshorensi) kwaye kufuneka silandele inkqubo ebanzi yasemthethweni njengoko ichaziwe apha ngezantsi.

2.5.3 Emva kokuba luvunyiwe uDluliselo Olucetywayo yiPrudential Authority, i-Emerald Life yiyo ezakuba yinkampani yee-inshorensi yeePolisi Ezidluliswayo.

3. **Ingaba kufuneka unike imvume yokudluliselwa kwepolisi yakho?**

Hayi. Akudingeki mvume yomnikazi wepolisi ukwenza udluliselo ngokwemimiselo yecandelo lama-50 loMthetho wee-Inshorensi.

4. **Kuya kwenzeka ntoni ukuba ngaba luvunyiwe uDluliselo Olucetywayo?**

4.1 Nanjengoko kungekho mvume idingekayo, kukho inkqubo ebanzi yasemthethweni emiselweyo kuMthetho wee-Inshorensi kwaye uDluliselo Olucetywayo kufuneka luvunyiwe yiPrudential Authority.

4.2 Ukhuselo lwepolisi ngokubhekiselele kwiiPolisi Ezidluliswayo alusayi kutshintsha kwaye neenzuzo zepolisi ziya kuhlala zikhuselekile.

4.3 Utshintsho oluya kubakho kuphela kukuba emva kokuvunywa koDluliselo Olucetywayo yiPrudential Authority, iiPolisi Ezidluliswayo ziya kumelwa yi-Emerald Life hayi iLion Life njengoko bekunjalo ngaphambili.

5. **Ingaba iinzuzo zepolisi ziya kuhlala zikhuselekile?**

6.2.1 I-Lion Life ne-Emerald Life zingenise isicelo sokuvunywa koDluliselo Olucetywayo kwiPrudential Authority;

- 6.2.2 Iintloko zamacandelo othelekelelo lwemirhumo zaseLion Life kunye nase-Emerald Life zikhuphe iingxelo malunga nokwamkeleka koDluliselo Olucetywayo;
- 6.2.3 I-Prudential Authority iyinikezile inkxaso eyeyokuqala yoDluliselo Olucetywayo kwaye iyivumele iLion Life kunye ne-Emerald Life ukuba zinganxibelelana nabanikazi beepolisi ngokuphathelele kolu tshintsho, nanjengoko kudingeka ukuba zikwenze oko ngokwemimiselo yoMthetho wee-Inshorensi; futhi
- 6.2.4 Isaziso soDluliselo Olucetywayo sipapashiwe kumaphephandaba awohlukeneyo kwakunye nezinye iindlela zonxibelelwano ukuqinisekisa ukuba bonke abanikazi beepolisi bafumana isaziso esaneleyo ngoDluliselo Olucetywayo.
- 6.3 Nawuphi na umnikazi-polisi wePolisi Edluliswayo okanye naliphi na iqela elinomdla elichatshazelwa luDluliselo Olucetywayo angaqhagamshelana nePrudential Authority kunye/okanye ne-Financial sector conduct Authority malunga nawo nawuphi na umba onxulumene noDluliselo Olucetywayo ngaphambi komhla we-17 kweyeKhala 2026.
- 6.4 Ukuba ngaba kukho ophikisana nako ngokunxulumene noDluliselo Olucetywayo, kufuneka ungenise iziphakamiso kwiPrudential Authority kunye/okanye ne-Financial sector conduct Authority ngokutsalela umnxeba kunye/okanye uthumele i-imeyile kunye/okanye ubhalele kwiPrudential Authority okanye kwiFinancial sector conduct Authority. Ezi ziphakamiso kufuneka zingene kwiPrudential Authority okanye kwiFinancial sector conduct Authority ngaphambi komhla we-17 kweyeKhala 2026.
- 6.5 Ukuba ngaba akukho ophikisana nako ngokunxulumene noDluliselo Olucetywayo, akudingeki ukuba ungenise zincwadi zifungelweyo okanye wenze iziphakamiso. Yakuba iPrudential Authority ilwamkele uDluliselo Olucetywayo, ipolisi yakho iya kudluliselwa e-Emerald Life ngokuzenzekelayo.
- 6.6 Nceda uqaphele ukuba uNozikhhalazo wee-Inshorensi Zexesha Elide kunye noNozikhhalazo waBanikezeli beeNkonzo zeMali abasayi kukwazi ukukunceda ngokunxulumene nalo mba.
